

The intended use of the product/-s:

The product can be used directly on the board instead of or in combination with a Nylon Cover.

Slide the Cover over the Master Board to prevent the user from having direct contact with the board and thereby increasing the hygiene.

Correct use of the product:

Mount the Super Glide ECO Tube around the sliding board. The very slippery inner surface optimizes the transfer, minimizes the workload and improves the hygiene since the patient is not in direct contact with the board.

Warning:

Do not leave the product on the floor due to the risk of slipping and falling. Do not leave the product under the patient for a long time due to risk of local accumulation of heat.

Risk assessment:

Always make a risk assessment and a functional assessment of the user prior to using the product. This way using the product for transferring or moving a user, is ergonomic and legally sound.

Knowledge of the product/transferring:

Turning to sidelying in middle of the bed:



1. Bend the user's legs (Super Glide ECO can be used here) and turn the user slightly to one side. Place the Super Glide ECO Tube with a fold as close to the user as possible or under the draw sheet at the side you wish to turn the user towards.



2. Place the user's arms on the stomach or the pillow. Turn the user to the opposite side and slide the user to the perfect position using Super Glide ECO.



3. Remove the Super Glide ECO by pulling the lower part from one side. If you feel resistance pull the opposite lower side.

Higher up in bed – Dependant user, one helper:



4. Place the hand in the Super Glide ECO fold. From the top slide the Super Glide under the user's shoulders - begin on one side and continue the same way on the other side.



5. Elevate the bed end to use the gravity. Bend the user's legs, fixate the feet and ask the user to push the upper body upwards. Alternatively place the Super Glide ECO under the sheet and use this as a draw sheet.



6. Super Glide ECO glides under the user's shoulders and the user can easily slide upwards in bed with reduced friction. Remove the Super Glide ECO by pulling the lower part from one side. If you feel resistance pull the opposite lower side.

Sideways transfer with Super Glide ECO – Two helpers:



7. Turn the user to side lying. Helper A places the Super Glide ECO with the fold close to the spine. To achieve comfort and perfect working conditions a draw sheet could also be placed over the Super Glide ECO.



8. Turn the user back to supine lying and straighten the draw sheet. Helper B pushes the user to the side and Helper A pulls the draw sheet. The Super Glide ECO reduces friction enormously during the transfer.



9. Remove the Super Glide ECO by pulling the lower part of the Super Glide ECO.



Sideways transfer with Transferboard and Super Glide ECO – Two helpers:



10. Turn the user to side lying. Helper A places the Master/Vision Board with the Super Glide ECO - Tube around itself. Place it close to the spine. For comfort and optimal working conditions use a draw sheet.



11.Turn the user back to supine lying. Helper B pushes the user a bit onto the board and Helper A pulls the draw sheet. The Super Glide ECO – Tube circles around the board and reduces friction.



12. Push/pull the user to the oppersite bed. After the transfer, push the board towards a vertical position to remove the board. Alternatively cut the Super Glide ECO - Tube open with a pair of scissors, pull the board out and pull the lower part of the Super Glide to remove it.

Transfer between bed and chair:



13. Ask the user to lean to the opposite side. Place the Super Glide ECO under the user's lifted buttocks.



14. Place the Master Glide under the folded Super Glide ECO, to build the bridge and make the transfer easier. Remember to make use of the user's resources during the transfer.



15. Make the transfer. Remove the sliding board. Pull the lower part of the Super Glide ECO to remove it.

Turning with Super Glide ECO, Multi Sheet, and a hoist:



16. Mount the Multi Sheet on the hoist. Turn the user slightly to one side. Place the Super Glide ECO fold close to the spine. Make sure to place it under the pressure points of the head, shoulder, and buttocks.



17. Connect the Multi Sheet on the opposite side to the hoist. Lift up, slide, and place the user in a perfect position with the Multi Sheet and the Super Glide ECO. Thus, reducing friction between the mattress and the Multi Sheet.



18. Grab one side of the lower part of the Super Glide ECO and pull it out. If resistance is felt grab the opposite lower side instead and pull here.
